	Session Description As Disease Intervention Specialist (DIS) roles increasingly include various levels of referrals and linkage to HIV care and Pre-Exposure Prophylaxis (PrEP), new motivators and discussions with clients are needed to assist them in making personal decisions about HIV care and prevention. In this skills-building workshop designed for DIS, motivational interviewing techniques will be presented and practiced including examples of how Linkage to Care and PrEP referrals are implemented by DIS in a few health departments. Be prepared to engage with trainers and each other.

During 2012–2014, the number of reported congenital syphilis (CS) cases in the U.S. increased from 334 to 458, representing an increase in rate from 8.4 to 11.6 cases per 100,000 live births. Between December 2014 and March 2015, 12 cases of ocular syphilis were reported from two major cities, San Francisco and Seattle. Subsequent case finding indicated more than 200 cases reported over the past two years from 20 states. This session will provide a high level epidemiology update on the increases of congenital and ocular syphilis in recent years in the United States. Additionally, it will highlight the activities of project areas around the screening and response to each condition and identify best practices for prevention and control.

This discussion will focus on a phone app that was built by Maricopa County Department of Public Health's (MCDPH) Sexually Transmitted Disease (STD) Unit and released in July 2016. The application was created to provide Maricopa County residents with a convenient tool to improve and maintain their sexual and reproductive health and offers information on free/low cost testing locations, educational resources, partner referral (a way for an infected client to anonymously refer a partner for testing), and test results (for those tested at the Maricopa County clinic). The target demographic includes young adults (ages 16-25) and homosexual men who are residents of Maricopa County.

5. PRISM Networking, Collaborations, and Information Exchange (Ryan Kreisberg, Ryan.Kreisberg@azdhs.gov)

In an effort to increase interstate collaborations, active PRISM users from any jurisdiction are encouraged to come and share their experiences and resources. Topics may include but are not limited to: user management, data manipulation and analysis, best practices, etc.

6. Benefits of Using Chexout (Greta Anschuetz, greta.anschuetz@phila.gov)

This roundtable will focus on the benefits of using Chexout to text/email test results to patients. Discuss will be on the ease of setting up the system, cost benefit to Program, and acceptability by patients.

7. DIS Recruitment-How do you hire the right person? (Tammy Foskey, <u>Tammy.Foskey@dshs.state.tx.us</u>)

The DIS position is not made for everyone. What has helped you recruit the right person? What type of interview questions/activities do you use during an interview? 1. Using Electronic Health Records to Examine Rates of Chlamydia Among American Indians and Alaska Natives. *Contact: Andria Apostolou / <u>Andria Apostolou@ihs.gov</u>*

Chlamydia is the most frequently reported infectious disease in the US. American Indians and Alaska Natives (Al/ANs) are disproportionally affected. To evaluate utility of electronic health records for surveillance, we examined chlamydia rates among Al/ANs using the Indian Health Service discharge datasets.

2. PrEP Case Management: Retention Outcomes for HIV Vulnerable PrEP Initiates. *Contact: Bryan Bautista-Gutierrez* /BryanB@howardbrown.org

Overview of the PrEP retention and adherence to PrEP medication are significant concerns for medical providers initiating patients onto PrEP. Howard Brown Health's PrEP staff has created the PrEP Case Management program to ensure that communities that are vulnerable for HIV are being appropriately linked and retained to PrEP Care.

3. Achieving Health Equity among MSM: How is Your Jurisdiction Doing? *Contact: Tom Bertrand /* <u>Thomas.Bertrand@health.ri.gov</u>

In recent years, rates of infectious syphilis in the United States among men who have sex with men (MSM) have dramatically increased. The Gay Men's Health Equity (GMHE) Group, a joint effort of the National Coalition of STD Directors (NCSD) and the National Alliance of State and Territorial AIDS Directors (NASTAD), has developed a comprehensive tool (The MSM Health Equity Report Card) to assist state, city, and local health departments conduct institutional self-assessments on their progress towards achieving health equity among MSM, as well as facilitate peer-to-peer technical assistance.

4. Pre-exposure Prophylaxis Knowledge and Beliefs in Chicago Department of Public Health Disease Intervention Specialists. *Contact: Ramona Bhatia* / Ramona.Bhatia@cityofchicago.org

DIS are frequently in contact with populations vulnerable to HIV. This study explored DIS PrEP knowledge and beliefs in order to identify gaps that could be addressed in future trainings.

5. Taking an Active Approach to School-Based STD Screening at a High School Health Fair. *Contact: Colleen Bornmueller / <u>cbornmueller@fpcouncil.com</u>*

In 2015, through the work of the local Disease Intervention Specialist, county health department staff, and a Planned Parenthood Health Educator, the lowa Department of Public Health was able to facilitate a school screening at Burlington High School in conjunction with an annual school health fair. Thirty minute educational presentations were held and students (grades 8 – 12) were given the option to be tested for CT/GC after the presentations. Testing was confidential. Based on the success of the first year, a second event was held in 2016. We were successful in providing testing and education in a high school setting with buy-in and support from school administration and personnel, parents, and the

community. For the combined two-year period (2015-2016), we provided 118 tests to youth aged 14 – 19. There were 10 CT positives for a rate of 8.5%. Sixty-eight tests were provided to males (four positives) and 50 tests to females (six positives). In addition, six partners were and treated. The health fair proved to be a safe, non-stigmatizing venue for testing. Working with individuals at the local level made it easier to garner support. We identified infections and were able to treat youth that may not have otherwise sought testing. By having these data and the health fair model, we may be able to successfully pursue testing in other school districts.

6. CheckAfter: STD/HIV Phone App Targeting High Risk Populations, Maricopa County, AZ 2016. *Contact: Erica* Bouton / <u>EricaBouton@mail.maricopa.gov</u>

The poster focuses on a phone app that was built by Maricopa County Department of Public Health's (MCDPH) Sexually Transmitted Disease (STD) Unit and released in July 2016. The application was created to provide Maricopa County residents with a convenient tool to improve and maintain their sexual and reproductive health and offers information on free/low cost testing locations, educational resources, partner referral (a way for an infected client to anonymously refer a partner for testing), and test results (for those tested at the Maricopa County clinic). The target demographic includes young adults (ages 16-25) and homosexual men who are residents of Maricopa County.

7. The Implementation of a National Online Sexually Transmitted Disease Clinical Consultation Network (STDCCN). *Contact: Helen Burnside / <u>Helen.Burnside@dhha.org</u>*

Following significant changes to the United States healthcare system, community health centers and private providers are providing a greater amount of STD screening, treatment and management that, in the past, would have been performed at public health specialty (STD) clinics. However, general healthcare providers without a background in STDs may be unfamiliar with STD treatment protocols and unusual clinical presentations. To assist healthcare providers across the country, the Denver Prevention Training Center (PTC), part of the National Network of STD Clinical Prevention Training Centers (NNPTC), collaborated with the Southeastern National TB Center (SNTC) to modify their tuberculosis clinical consultation database to serve clinicians screening for and treating STDs.

8. Developing Academic Detailing and Patient Empowerment for Addressing Private Practice Chlamydia Screening and Treatment. *Contact: Beth Butler / <u>bebutler@pa.gov</u>*

Routine provider adherence to screening recommendations, including chlamydia screening, is paramount to the sexual and reproductive health of young women, yet screening rates remain subpar. Although changing screening practices of private providers can be a daunting task for Public Health, improvement in these settings is key. Partnering with a health plan with established relationships with these providers may provide the leverage needed to shift behavior.

9. SyphAware: A Multi-level Social Marketing Campaign For Syphilis Prevention. *Contact: Joshua Ferrer / Joshua.S.ferrer@dhsoha.state.or.us*

Like many other states, Oregon has experienced a resurgence of syphilis. From 2007 to 2015, rates of primary and secondary syphilis increased over 1500% across the state, with the majority occurring along the I-5 corridor in the Portland-Metropolitan area among Men who Have Sex with Men. In response to feedback from researchers from the Centers for Disease Control and Prevention who conducted an Epi-Aid on the syphilis epidemic, the Oregon STD Program launched a multi-level social marketing campaign, SyphAware, in November 2015. A variety of transit advertising and a dedicated website were employed in an effort to create community-wide awareness that syphilis remains a serious health issue and that syphilis rates have increased. These were accompanied by outreach efforts to medical providers statewide including a 'Dear Colleague' letter with updated screening recommendations. Social marketing campaigns employing transit advertising can be a useful tool to generate community-wide awareness and conversations around often taboo health topics and also present a beneficial platform to educate medical providers on new trends in disease rates while encouraging them to make changes to their screening practices.

10. How Perception of Barriers and Risk Influences the Likelihood of STD Testing, Stratified By Gender and Age; Boise, Idaho 2015. *Contact: Diana Gardner / <u>GardnerD@dhw.idaho.gov</u>*

Perceived barriers and risks influencing STD testing in young adults in Boise, Idaho remains undefined. Young adults were surveyed in seven settings, with the goal of better understanding knowledge, attitudes and perceptions about STD testing in order to enhance STD prevention and diagnosis efforts in this population. Conclusions: Results stratified by gender showed more females than males, overall, would seek testing in the same sexual risk circumstances. Respondents 17 years and younger were less likely to seek testing under the majority of circumstances. Findings of this study suggest that increased education for STD prevention and diagnosis is needed for young adults living in Boise, Idaho.

11. Home Self-Collected Vaginal Swabs Compared to Clinic Self-Collected Vaginal Swabs for Detection of *Chlamydia trachomatis* and *Neisseria gonorrhoeae*. *Contact: Dr. Charlotte Gaydos / <u>cgaydos@jhmi.edu</u>*

Self-collection of vaginal swabs are acceptable to women, yet no commercial company has studied the accuracy of homecollected swabs. The objective of this study was to compare accuracy of clinic self-collection vs. home self-collection of vaginal swabs for the detection of chlamydia (CT) and gonorrhea (NG).

12. Case Definition for Syphilis with Neurologic Involvement May Not Detect Important Changes in the Epidemiology of Neurosyphilis. *Contact: Robin Hennessy / <u>rhenness@health.nyc.gov</u>*

Syphilis with neurologic involvement (neurosyphilis – NS) is a rare manifestation that can have serious manifestations (ie: blindness) and can occur at any stage of syphilis infection. The case definition for NS is conservative and may undercount cases of this potentially serious condition, which could have ramifications for detecting changes in the epidemiology of NS.

13. Condoms (STILL) Work!: Increasing the Impact of Public/Private Partnerships in Condom Messaging. *Contact: Stephen Hicks / shicks@ncsddc.org*

The National Coalition of STD Directors (NCSD) and Church & Dwight, the maker of Trojan[™] brand condoms, have developed a standing partnership wherein Trojan donates 1,000,000 condoms each calendar year, as part of the Condoms (STILL) Work! campaign, which distributes condoms to health departments and clinics with the greatest STD burden and resource need. From January 2016 – August 2016, nearly 830,000 condoms have been distributed. The partnership also emphasizes lubricant use, so donations of lubricant are made to health departments and clinics. The map (right) highlights the states and cities that received Trojan[™] brand condoms donations throughout the program's history.

14. Fundamentals of Policy and Communications to Address Public Health Issues. *Contact: Rebekah Horowitz / <u>rhorowitz@ncsddc.org</u>*

Every day, US health departments engage in policy efforts to improve the public health of local communities. However, getting change to happen is often a big lift, takes time, and requires a team effort.

15. Policy Approaches to Address Rising Rates of Congenital Syphilis. *Contact: Rebekah Horowitz / <u>rhorowitz@ncsddc.org</u>*

Nationwide, rates of syphilis are increasing. In 2014, the most recent data, the number of congenital syphilis (CS) cases was the highest it had been since 2001. If left untreated, women who acquire syphilis before or during pregnancy are at risk for transmitting the infection to the fetus. In fetuses, CS is linked to premature birth, stillbirth, and death shortly after birth. Untreated CS may also result in developmental problems in multiple organs. The CDC recommends that all women should be screened for syphilis at their first prenatal visit and those who are at high risk for syphilis, previously untested, or live in areas of high syphilis morbidity should be screened again early in the third trimester.

16. Developing an Automated System for Assigning Reactor Dispositions.

Numbers of cases of STDs in San Francisco have continued to rise faster than increases in program resources, which has forced us to examine efficiencies of our activities. Protocols for follow-up of reported reactive serologic tests for syphilis ("reactors") were developed years ago when the number of syphilis cases were much lower than today, syphilis elimination was our primary concern, and our computer system was less capable of automation. Our objective was to see whether we could automatically remove results reported on old cases from the manual review of new reactors, leaving us with more time for other activities.

17. AAPPS and STD Safety Net Clinical Preventive Services: A Summary of the 2014 STD AAPPS Administrative Reporting Results. *Contact: Jennifer Ludovic / bmp8@cdc.gov*

Investments in the healthcare system as a result of the Affordable Care Act are predicted to increase the proportion of insured individuals. To ensure the safety-net population is continuing to be reached, the Improving Sexually Transmitted Disease Programs through Assessment, Assurance, Policy Development, and Prevention Strategies (STD AAPPS) Funding Opportunity Announcement required awardees to provide at least 13.5 percent of the overall award amount to non-profit organizations that have demonstrated their ability to provide safety-net STD clinical preventive services. Our objective was to assess whether the 13.5 percent funds were successful in reaching at-risk, vulnerable populations. The poster highlights results of this data.

18. Michigan Outbreak of Lymphogranuloma venereum (LGV) 2015- 2016. *Contact: Kathryn Macomber / <u>MacomberK@michigan.gov</u>*

After a dozen years with no reported cases, Michigan documented 42 cases of LGV between June 2015 and May 2016, all among HIV+ MSM. The poster provides background and an epidemiologic description of this re-emerging infection in Michigan.

19. Evaluation of the Performance of a Rapid Syphilis Test, Syphilis Health Check[™], using finger-stick specimens in an STD Clinic in Escambia County, Florida, 2016. *Contact: James Matthias* / James.Matthias@flhealth.gov

In December 2014, the U.S. Food and Drug Administration granted the first-ever Clinical Laboratory Improvement Amendments waiver for a rapid treponemal syphilis screening test, Syphilis Health Check[™] (SHC[™]). We evaluated the performance of SHC[™] in comparison to treponemal and non-treponemal tests routinely used in an STD clinic.

20. Pilot Project of Self-collected Specimens for Express Gonorrhea and Chlamydia Tests with Adolescents and Young Adults at Youth Clinics, San Francisco, 2016. *Contact: Trang Nguyen / <u>trang.nguyen@sfdph.org</u>*

Reducing inequities in chlamydia (CT) and gonorrhea (GC) screening and positivity among youth ages 15-25 is a San Francisco Department of Public Health (DPH) priority. In 2014, the CT and GC rates were 3 times and 1.5 times greater, respectively, for youth than adults >25 years. Among Black/African-American youth, the CT rate was 5.9 times greater than for white youth; the GC rate was 6.5 times greater. We sought to increase screening with self-collection express visits.

21. Implementation of Extra-genital Gonorrhea (GC) and Chlamydia (CT) Screening at Louisiana Parish (County) Health Units. *Contact: Dr. Cornelis Rietmeijer / <u>kees@rietmeijer.us</u>*

Louisiana ranks at or near the top in the nation for GC and CT case rates with 25–28% of cases identified at parish health units (PHU). Louisiana's Targeted Evaluation Plan was developed to evaluate extra-genital (rectal and pharyngeal) positivity rates at PHUs.

22. Lessons Learned for Targeted STD/HIV Outreach Services to High Risk Populations in Guam. *Contact: Bernadette Schuman / <u>Bernadette.Schumann@dphss.guam.gov</u>*

On Guam, Gonorrhea and Chlamydia screening rates demonstrated over a 20% positivity rate among STD/HIV Program (SHP) clients. SHP initiated a CBA Request Information System (CRIS) with CDC. An integrated STD/HIV Targeted Testing strategy was developed and implemented in January 2016 to reach the most at risk populations. Based on client interviews, targeted testing efforts were expanded to include the local migrant population who are engaging in risky behaviors with MSM.

23. Increasing Annual Syphilis and Rectal Gonorrhea Screening in Men Who Have Sex With Men (MSM) at a Federally Qualified Health Center with an LGBT Focus in Illinois, 2015. *Contact: Marguerite Smith / <u>Marguerite.Smith@illinois.gov</u>*

Current screening recommendations state that men who have sex with men (MSM) should be screened annually for syphilis and for rectal gonorrhea if they have receptive anal intercourse. As part of a Centers for Disease Control and Prevention Targeted Evaluation Plan, the Illinois Department of Public Health STD Program collaborated with Howard Brown Health (HBH) to increase annual syphilis and rectal gonorrhea screening among MSM.

24. Public Health and Education Partnerships for Adolescent Sexual Health Services (SHS): Lessons from the Field. *Contact: Sara Stahlberg / sstahlberg@ncsddc.org*

Young people under 25 account for nearly half of all reported sexually transmitted diseases (STDs). Access to quality sexual health services (SHS), sexual health education, and safe and supportive environments plays a critical role in reducing risky sexual behavior among youth. Because of their unrivaled access to adolescents, education agencies are well-positioned to have a meaningful impact on sexual health outcomes. Health departments, and specifically STD programs, are natural partners in this work—specifically when facilitating access to and providing key SHS.

25. Novel Outbreak Detection Method For Sexually Transmitted Infections In Virginia. *Contact: Jeffrey Stover / Jeff.Stover@vdh.virginia.gov*

Novel statistical methods are needed to analyze incidence data of sexually transmitted infections (STI) as a means of detecting aberrations or outbreaks. Regression analysis of cumulative STI incidence data in Virginia was conducted (Summer of 2016) to minimize errors and noise. Two regressions of the cumulative incidence data were fitted using a dynamic breakpoint to identify the potential onset of an outbreak. The residuals of the full data set were compared with the pre-aberration regression line; disease incidence was estimated above the predicted disease burden. The slope of the first fitted regression line of the accumulated cases provides the fitted case rate pre-aberration, while the slope of the second fitted line provides the case rate after the aberration. The initial date of aberration in incidence of STI's in Virginia and the severity of the aberration was estimated by identifying the breakpoint between the two regression slopes. Additional analyses and refinement related to this statistical concept for aberration detection is ongoing.

26. Identification of Undiagnosed HIV Infections among Contacts of HIV+ Males Newly Diagnosed with Gonorrhea or Chlamydia, 2005-2015. *Contact: Karen Surita / <u>Karen.Surita@dshs.state.tx.us</u></sup>*

The poster will display outcomes and provide recommendations from a study analysis of males \geq 15 years diagnosed with chlamydia (CT) and/or gonorrhea (GC) infection in Texas between January 1, 2005 - December 31, 2015 with an HIV diagnosis date \geq 30 days prior and who were reported to Texas' HIV and STD surveillance systems. The primary outcome evaluated was the Number Needed to Treat (NNT), defined as the number of partner services investigations initiated per new HIV diagnosis among named contacts as a result of partner services.

Beyond Partner Services: Applying Motivators to Linkages to Care and PrEP

Jae Egan is an employee of the California Department of Public Health, STD Control Branch, and provides training and technical assistance to local health jurisdictions throughout the State, focusing on STD/HIV service integration, STD/HIV education, and the HIV Partner Services intervention, an intervention which assists HIV positive individuals in disclosing their HIV status to sex and needle-sharing partners. Also as an employee of the State STD Control Branch but out-stationed in San Diego County at the HIV, STD, and Hepatitis Branch of Public Health Services, Jae worked as an HIV Test Counselor and Disease Intervention Specialist where he conducted HIV and syphilis field investigations, follow-up, partner notification, and case management. Prior to this time, Jae worked with the San Diego County HIV Prevention Program providing training and technical assistance to the locally funded HIV Prevention Providers as well as logistical support to the HIV Prevention Community Planning Group.

Taylor Johnsonbaugh has worked in the field of sexual health and STD/HIV in multiple capacities for the last 8 years. She worked in Indianapolis, IN as a sexual health educator for inner city girls with Girls, Inc, a Disease Intervention Specialist both in rural and urban settings for both Planned Parenthood and Marion County Health Department, and as the Quality & Clinic Testing Coordinator for HIV Expanison, which was an innovative program implementing routine, non-risk based, rapid HIV testing at 10 of Eskenazi Health's primary care clinics. While working for Eskenazi, she also assisted on many levels with the recent HIV outbreak in southern Indiana. Most recently, she has become the Field Services Consultant for NW Washington. She actively works with her covered counties to aid and educate in providing the community with the best resources for accessing services related to STDs & HIV, including PrEP.

Greg Mehlhaff is the Deputy Director of the CA Prevention Training Center. In his 18+ year tenure he has also coordinated the HIV Partner Counseling and Referral Services Training Program and held the HIV/STD Liaison position coordinating HIV/STD integration efforts at the CBO, local and state government levels. Greg directed the efforts of the CAPTC on their project titled "Enhancing HIV Counselor Training in the Republic of Uganda" for 2 years traveling to Uganda five times to provide direction, capacity building and training. Greg has been one of the leads in the process of disseminating the RESPECT intervention nationally supporting the DEBI initiative from the CDC. For the past 2 years Greg has lead the development of a new course titled *HIV Linkage to Care for DIS* in collaboration with the University of Washington. Prior to coming to the CAPTC he worked in the CBO setting in all areas of HIV prevention and care for 6 years, developing, implementing, evaluating and directing programs. Greg is committed to enhancing the skills of training participants which reflect the reality of their daily activities and of the people they serve.

Megan Rei received her MPH in 2012 from the University of South Florida. She has been with the Virginia Department of Health for the past 4 years, currently holding the position of Northern Virginia Regional DIS Coordinator. She has previously been a DIS in Prince William County, where she acted as one of Virginia's active referral specialists (DIS specially trained in linking HIV patients to care). Megan has also played an important role in developing policies and procedures for Virginia's Field Operations Manual.

<u>Collectively Addressing STIs in Indian Country: Open Session – Search Conference</u> <u>Framework</u>

Philene Herrera for 27 years worked in public health as a Family Planning Counselor, then becoming the Health Program Manager of the Navajo Nation Department of Health, Health Education & HIV Prevention Programs, and the Teen Pregnancy Prevention Program, servitude to the Navajo Nation included program planning & evaluation, policy development and addressing legislated amendments, QI Coordinator, and is a representative to the National Indian Health Board Tribal Public Health Accreditation Advisory Board and serves as an Alternate to the Department of Health & Human Service Office of Minority Health Research Advisory Council. For the past year, she has an additional responsibility as the Acting Director of the Navajo Special Diabetes Project overseeing eight field offices and five wellness centers, actively contributing to creating short & long term program service goals, evaluating program performance in health education, physical activity, nutrition education, monitoring program activities, assuring internal & fiscal controls and procedures guide program accountability.

Jessica Leston works full time at the Northwest Portland Area Indian Health Board as the HIV/STD/HCV Clinical Programs Manager. She has been working in the Sexual Health Field for the past 11 years in Indian Country, beginning in Alaska and then moving to the Northwest Portland Area Indian Health Board to partner with the Indian Health Serve to do more National-scope work. She has a Master's Degree in community health practice. Around the field of sexual health she has worked on a variety of projects, including: social medial and marketing; website and outreach development; community and individual-level education; CDC approved prevention interventions and adaptations of CDC prevention interventions for Indian Country; and clinical education for HIV/STD/HCV screening and adolescent health specific screening, including rights of consent for treatment as a minor. Specifically around adolescent sexual health, she has been involved with: youth trainings and education (including Native STAND, Native IYG, and Native VOICES); focus groups and interviews; and research studies to provide adapted interventions for Native youth. More recently she started her DrPH at the University of Illinois, Chicago.

Loriann Wunder is a Public Health Educator with the Wisconsin Division of Public Health's STD Control Section. Ms. Wunder has been working in the field of STD Control for over 25 years. She began her career with CDC as a DIS for the Chicago Board of Health, and after a few years accepting a state position in Wisconsin. Currently, Ms. Wunder's main focus is providing training and technical assistance to local city and county health departments statewide.

"Let's talk about STD Prevention!" - Messaging and Communications Tools for STD Programs

Dr. Diane Dlouhy has worked with the CDC for five years—starting out as a Disease Intervention Specialist in Miami and then relocating to headquarters in Atlanta to join the Division of STD Prevention's (DSTDP) Office of the Director. She has a strong medical background as a graduate of the University of Southern California's Keck School of Medicine. Dr. Dlouhy is a member of DSTDP's communication team and is the primary contact for all public inquiries received by the Division. Experience in the field as well as continued patient/provider interactions via public inquiries have given her a unique perspective on the communication needs of her Division's target audience.

Kellie Mullen, a recovering reporter, applies two decades of expertise in executive media coaching, messaging and storytelling for the clients of Ogilvy. Kellie's tenure in TV and radio newsrooms provided Kellie with an insightful media mindset – understanding the criteria for news, the elements of a powerful story, as well as effective communication techniques. Kellie translates her knowledge of the newsroom to clients through executive media coaching and presentation coaching sessions. For six years, Greta worked closely with the STD Control Program to use their data to help drive program changes, as well as having a major role in completing their grant applications. Update from the CDC Division of STD Prevention

Dr. Gail Bolan is the Director of the Division of STD Prevention in NCHHSTP at the Centers for Disease Control and Prevention (CDC). A graduate of Dartmouth Medical School, she completed her training in internal medicine at the University of Virginia, Charlottesville. She received subspecialty training in infectious diseases at the Tufts New England Medical Center and the Stanford Medical Center and in medical epidemiology as an Epidemic Intelligence Service (EIS) officer at CDC in the Respiratory and Special Pathogens Branch. Prior to joining CDC in February 2011, she served as the Chief of the STD Control Branch at the California Department of Public Health from 1997 to 2011, and as the Director of the San Francisco City and County STD Prevention and Control Program and as Medical Director of San Francisco City Clinic from 1987 to 1997. She directed the California STD/HIV Prevention Training Center for over 20 years.

DIS Certification Update

Dr. Robert Kirkaldy is currently the team lead for the Epidemiology Research Team in the Division of STD Prevention. For the past six years, he oversaw US surveillance of gonococcal resistance as the project officer and epidemiologist for the Gonococcal Isolate Surveillance Project (GISP). When Partner Services and Technology Collide: Delivery of Online Intervention Services

Rachel Kachur is a Health Communication Specialist in the Division of STD Prevention at the CDC. Ms. Kachur's work includes STD prevention with a focus on technology and its influence on sexual health. She is particularly interested in the ways in which technology is used for STD partner services and prevention. She also works closely with state and local programs on the use of technology for STD partner services and prevention.

Marlo Tonge serves as one of the managers for the Office of Epidemiology & Disease Surveillance (OEDS) the the Southern Nevada Health District and her responsibilities have been focused on integrating staff and technological processes, cross divisional collaboration, community engagement, reducing stigma of communicable diseases, and mediation. Marlo works with the legal system to address community members resistant to mandates related to infectious disease and with employees not following protocols, or meeting program objectives. Syphilis Through the Ages: An Update on Congenital and Ocular Syphilis

Dr. Anna Cope is a Field Epidemiologist for the Division of STD Prevention at the CDC. She is currently assigned to the North Carolina Division of Public Health where she works on analyses to improve the understanding of the local epidemiology of syphilis, chlamydia and gonorrhea. Dr. Paul Bloomquist joined the Indian Health Service in 2006 and has never looked back. After a concentration on family medicine and diabetes care, Dr. Bloomquist began practicing HIV medicine at the Phoenix Indian Medical Center in 2008 and is continuously inspired by the work. He received an MD degree from the University of Minnesota Medical School in 1992, completing residency training at the University of Missouri, Columbia, Department of Family and Community Medicine in 1995. Dr. Bloomquist has collaboratively published articles on anti-retro viral therapy, lectured on HIV diagnosis and treatment, and is a local champion of STD screening, treatment and complicated case management.

Dr. Alithea Gabrellas received a BA from Harvard University, a MD from Thomas Jefferson Medical College and she completed her internal medicine training at the University of Pennsylvania. Gabrellas runs the HIV, Hepatitis C and tuberculosis clinics at Tsehootsooi Medical Center on the Navajo Nation. She also serves as the Infection Prevention Medical Officer for Tsehootsooi Medical Center and as the STI Prevention Officer for the Fort Defiance Service Unit. In this role Gabrellas coordinates with the Navajo Nation Department of Public health, and the medical and nursing divisions of Tsehootsooi Medical Center to ensure notification, treatment and partner testing for all STI cases. She also works with the Mobile Health Unit program to provide STI screening in the local community.

Dr. Jon Iralu serves as Chief Clinical Consultant for Infectious Diseases for the Indian Health Service and is a Senior Physician at Brigham and Women's Hospital in the division of global health equity in Boston, Massachusetts. He has a special interest in home-based care delivery for HIV, viral hepatitis, STDs and tuberculosis at rural locations in Indian Country.

David Stephens, BSN, RN, is the Multimedia Project Specialist for *We R Native*, at the Northwest Portland Area Indian Health Board (NPAIHB or Board). He has a unique blend of health promotion and IT experience – he is both a registered nurse and manages *We R Native*'s website, text messaging service, Facebook page, and YouTube channel – and all content creation therein. He has a knack for crafting compelling messages and images that generate youth likes, shares and comments. Stephens' work has focused on the design, development, and evaluation of multimedia programs to improve AI/AN adolescent sexual health using mixed methods community-based participatory research strategies, both regionally and nationally. David brings 7 years of experience running We R Native (www.WeRNative.org). We R Native empowers teens to get actively involved in their communities, health, and wellbeing using social media, text messaging, community service grants, and a website containing skill-building tools and links to medically accurate information. Most recently, David worked with youth advisors to develop Texting 4 Sexual Health, an innovative text message series that helped change Native youth's attitudes and behaviors around condom use and STD/HIV testing.

Rebecca Willis has been a certified nurse midwife since 2013. Through a grant from Columbia University, Rebecca began her midwifery and public health career in Bangladesh working for the Bangladeshi NGO, Gonoshasthaya Kendra (GK), where she provided trainings on neonatal resuscitation, management of the second and third stages of labor, and perineal suturing for birth attendants working in rural areas. In 2014, she returned to New York City to work as a staff

midwife at Elmhurst Hospital in Queens where she was able to continue serving Bangladeshi immigrants. In 2015, she moved to Navajo Nation to work at Tsehootsooi Medical Center in Fort Defiance, AZ. Her primary focus in the past year has been implementing a Mobile Women's Health Clinic to reach women in the most isolated parts of the reservation. The unit is a converted RV with two exam rooms and is staffed by 1-2 midwives, a lab technician, and a nurse. Women are able to receive STI testing, pregnancy care, family planning including IUD insertions, vaccinations, and well-woman annual exams including pap smears. The unit goes out twice per month and often integrates other hospital departments, such a physical therapy, public health nursing, and mammography. The unit plans to initiate STI testing for male patients in the coming months.

Terra Yabeny has worked in public health for 15 years, in the areas of substance abuse and injury prevention; maternal and child health; chronic disease; and communicable diseases. She is currently employed by Navajo Health Education Program as a Health Educator. Terra's primary responsibilities include informing, educating and empowering individuals, families, and tribal communities about health issues. She holds a Masters of Public Health from New Mexico State University and a Bachelor of Community Health from New Mexico State University. Terra is also completing her doctoral degree in Public Health with a focus on STD/HIV Prevention and Sexual Health at Walden University.

Michelle Allen currently serves as the Director of Maternal and Child Health (MCH) for the Georgia Department of Public Health (DPH). Improving Programs, Care, Health Equity and Messaging For Gay/Bi Men

Thomas Bertrand is currently the Chief of the Center of HIV, STDs, Viral Hepatitis, and TB at the Rhode Island Department of Health. Prior to this role, Tom worked as the Executive Director for AIDS Project Rhode Island, as well as the STD Director for the Massachusetts Department of Public Health. Tom has a Master's in public health in epidemiology from the State University of New York at Albany and an undergraduate degree in biology from Vassar College. Tom has approximately 22 years of experience in the field of public health where he has focused his efforts on primarily on STD and HIV prevention and control. Tom is a certified HIV test counselor in Rhode Island where he volunteers his time participates in rapid HIV testing clinics in a variety of community settings that reach high-risk individuals. Dr. B. W. Furness is a DSTDP Medical Epidemiologist who has been embedded in the Washington, DC DOH since 2002. He has acted as the Chief, Division of STD/TB Control and as the Chief Medical Officer of the Southeast STD Clinic. Furness is also a volunteer physician at Whitman-Walker Health's Gay Men's Health & Wellness Clinic and is a CDC representative on the year-long multi-institution collaboration "Transforming Primary Care for LGBT People" with Fenway Health, Weitzman Institute, and NACHC.

Dan Wohlfeiler is Chief of the Office of Policy, Communications and Planning at the Sexually Transmitted Disease Control Branch at the California Department of Public Health. He has worked in STD and HIV transmission since 1986, in Spain, Central America, and at the World Health Organization's Global Programme on AIDS. From 1990 to 1998, he served as Education Director for the STOP AIDS Project in San Francisco, the nation's largest community-based organization dedicated to HIV prevention among gay and bisexual men. "The Real World of STD Prevention" - From Evidence to Practice

Dr. Susan Blank is a board-certified Pediatrician, with a Master's degree in Public Health. After completing her residency at Yale-New Haven Hospital, she join CDC's Epidemic Intelligence Service in Environmental Health. Thereafter she began her work with the Division of STD Prevention, and was assigned to the NYC Department of Health and Mental Hygiene, where she currently directs the Bureau of STD Control. The Bureau includes ~ 300 staff, 8 STD clinics, units for Surveillance and Epidemiology, Policy, Assurance, Technology Initiatives, budgeting, and human resources. Secondarily, she has begun to make significant research contributions in the application of epidemiologic principles to the translation of research questions in Pediatrics. She teaches and mentors graduate medical and public health students.

Dr. Kees Rietmeijer, PhD, MD, MSPH, works as an independent STI/HIV prevention consultant. Dr. Rietmeijer is a graduate of the University of Amsterdam where he received his Medical Degree in 1977 and completed his residency in family practice in 1981. STD Smack Down! Should Chlamydia be a Reportable Condition?

Beyond the Clinic Walls: Leveraging Resources to Advance Adolescent Sexual Health

She recently graduated from Terra Linda High School, located in a suburban community where the majority of the students in her school district are Latinx, and the gross majority of us are on free and reduced lunch. There is a huge educational equity gap, and the 4 year college enrollment rate for Latinx students is less than 10%. Teen pregnancy is a prominent issue in her community and for the last 3 years she has worked to improve the resources and information students receive by changing district policy and installing condom machines in the three high schools. She has really enjoyed working in her hometown and has just recently learned the power of working on a national level, but she still feels that it is important to work in local communities that are still struggling. She believes in the power of young women making direct change in their communities. Sex education and women's health rights has become her passion and she looks forward to gaining the skills to continue her fight for women's access to health care, both at home and around the world.

Elizabeth Haller is the State Implementation Team Lead in the Program Development and Services Branch in the Division of Adolescent and School Heath located in the National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention at the Centers for Disease Control and Prevention. TEPs: Terrific, Tricky, or Tiresome? Sharing Experiences from the AAPPS Targeted Evaluation Work

The Real World: PrEP Implementation, Evaluation, Lessons Learned and What the Future Looks Like

Greta Anschuetz is currently the Surveillance Unit Manager for the STD Control Program within the Division of Disease Control for the Philadelphia Department of Public Health (PDPH). She began her career with PDPH in 2006 as the STD Control Program Epidemiologist. For six years, Greta worked closely with the STD Control Program to use their data to help drive program changes, as well as having a major role in completing their grant applications. She has been the STD Surveillance Unit Manager since June of 2012, and has since worked to expand the collaboration with their HIV program, led the migration of their surveillance system to a new platform, and continues to conduct data analyses to help drive program advancements.
